- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 5. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 6. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.

- 7. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers

offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

- 8. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 40% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.
- 9. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:
 - i. If number of technically qualified bidders are only 2 or 3.
 - ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
 - iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
 - iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Generic

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

- i) The Seller fails to comply with any material term of the Contract.
- ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

4. Generic

Manufacturer Authorization: Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid

5. Generic

While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.

6. Sample Clause

After award of contract – Successful Bidder shall have to get advance sample approved from buyer before bulk manufacturing / starting bulk supplies. Successful Bidder shall submit

samples for Buyer's approval, within 15 days of award of contract. Buyer shall, as per contract specifications framework, either approve the advance sample or will provide complete list of modification required in the sample within 7 days of receipt of advance sample. Seller shall be required to ensure supply as per approved sample with modifications as communicated by Buyer. If there is delay from buyer side in approval of advance sample – the delivery period shall be refixed without LD for the period of delay in sample approval. In case, the sample is found to have major deviations / not conforming to the Contract specifications, the buyer at its discretion may call for fresh samples for approval before allowing bulk supplies or may terminate the contract after notifying the deviations to the seller. Unless otherwise provided in the contract, all samples required for test shall be supplied by the contractor free of cost. Where under the contract, the contractor is required to submit an advance sample, any expenses incurred by the contractor on or in connection with the production of stores in bulk, before the sample has been approved unconditionally shall be borne by the Seller and he shall not claim any compensation in the event of such sample being found unacceptable by the Buyer / Consignee.

7. Financial Criteria

NET WORTH: Net Worth of the OEM should be positive as per the last audited financial statement.

8. Scope of Supply

Scope of supply (Bid price to include all cost components) : Only supply of Goods

9. **Certificates**

ISO 9001: The bidder or the OEM of the offered products must have ISO 9001 certification.

10. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

11. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

01. Pre-dispatch inspection at Seller premises (Fee/Charges to be borne by the SELLER): Before dispatch, the goods will be inspected by Buyer/ Consignee or their Authorized Representative or by Nominated External Inspection Agency (independently or jointly with Buyer or Consignee as decided by the Buyer) at Seller premises for their compliance to the contract specifications. Fee/ Charges taken by the External Inspection Agency and any external laboratories testing charges shall be borne by the SELLER. For such testing, Seller will provide necessary facilities free of cost. Seller shall notify the buyer through email about readiness of goods for pre-dispatch inspection and Buyer will notify the Seller about the Authorized Representative/ No minated External Inspection Agency and the date for testing. The goods would be dispatched to consignee only after clearance in pre-dispatch inspection. Consignee's right of rejection as per GTC in respect of the goods finally received at his location shall in no way be limited or waived by reason of the goods having pre viously been inspected, tested and passed by Buyer/ Consignee or its Nominated External Inspection Agency prior to the good's shipment. While bidding, the sellers should take into account 7 days FOR INSPECTIO N from the date of email offering the goods for inspection. Any delay in inspection beyond 7 days shall be

on the part of the buyer and shall be regularized without Liquidated Damages. Inspection and external lab oratory testing charges shall be borne by the supplier and it shall not be reimbursed by Buyer to them at a ny point in time. Cost of inspection/ testing shall be factored in by the supplier in the cost of the product it self while submitting bid. Following are the tests that are required to be conducted during pre-dispatch inspection: As per detailed parameters of QRs Specification approved by MHA vide letter no. IV-21011/3/2010-Prov-I dated 15/12/2014. INSPECTION AGENCY: The inspection agency will conduct the inspection and submit the certificate to the supplier as well as the buyers and all consignees. The bidder will be solely responsible for quality assurance of stores including pre-dispatch inspection/ testing at manufacturer's site by NITRA or Textiles Committee only.

- 2. As per Rule 175 of GFR 2017any omission, suppression and non disclosure of the information by the bidd er may lead to rejection of the bid. And as per the clause 5.1.4(IX) of the Manual for Procurement of Goods, 2022, a bidder shall not have conflict of interest with other bidders. Such conflict of interest can lead to ant i-competitive practices to the detriment of procuring entity's interests. The bidder found to have a conflict of interest shall be disqualified.
- 3. As per Guidelines for procurement through GeM vide letter no-U-II-98 (GeM Instruction)/2019-20 -Prov-1 4 dated 04/06/2019 in para 3 (H) ,The lab test report, should not be older than 5 years from date of publish ing of bid.
- 4. **Testing of Sample**: The testing of advance sample from NABL accredited Lab and PDI will be carried by NITRA or Textiles Committee only. The testing charges are to be borne by sellers.
- 5. Warranty period minimum 01 year should be applicable as per GTC of GeM. OEM Warranty certificate m ust be submitted by successful bidder at the time of delivery of Goods.
- 6. As per para-9.7.10, Manual for Procurement of Goods if the delivery of store is done after the expiry of the original delivery period, the CA/buyer will recover, from the contractor, as liquidated damages a sum equivalent to 0.5 (half) percent of the prices of any portion of stores delivered late, for each week or part ther eof for the delay. 7.Bidders are required to submitted a notarized affidavit on Rs 100/- stamp paper that the firm/vendor never submitted fake/forged document in Govt. department in last three years. Certificate s hould be after publication of bid.
- 8. As per para-7 pf the General Terms and Conditions on GeM 4.0 (Version 1.10) dated 2nd May 2023, Perf ormance Security must be submitted by the vendor to the Buyer within 15 days of award of contract on Ge M. In case of delay in sub mission of performance security, it may be treated as breach of contract and the procuring entity will be free to take ex-parte decision on the matter. No interest shall be payable on perfor mance security or ePBG or any amount payable by the seller to the buyer.
- 9. No advance payment of any type shall be made by the procuring entity to the contractor.
- 10. EMD required to be submitted the bidders in the form of Bank guarantee of GeM portal in the prescribe d format. Scanned copy of the same shall be uploaded by the seller in the online bid and hard copy of the same will have to be submitted directly to the buyer within 05 days of bid opening.
- 11. Pre-dispatch inspection shall be carried by the seller in a one lot. partial pre-dispatched inspection will not be accepted at any stage.
- 12. Fall Clause: The following Fall clause will from part of the contract placed on successful bidder:-
- a) The price charged for the stores supplied under the contract by the seller shall, in no event, exceed the lowest prices at which the seller sells the stores or offers to sell stores of identical description to any perso ns/Organisation, including the purchaser or any department of the Central government or any Department of state government or any statutory undertaking of the central or state government as the case may be d uring the period till performance of all supply orders place d during the currency of the contract is complet ed.
- b) If, at any time, during the said period the seller reduces the sale price, sells or offers to sell such stores to any person/organisation, including the buyer or any department of central Government or any Department of State Government or any Statutory undertaking of the central or state Government, as the case may be, at a price lower than the price chargeable under the contract, he shall forthwith notify such reduction or sale or order of sale to the CoBRA HQ and the price payable under the contract for the stores of such reduction of sale offer of the sale shall stand correspondingly reduced. The above stipulation will, however, not apply to:-
- i- Exports by the seller.

- ii- Sale of goods as original equipment at price lower than the price charged for normal replacement.
- iii- Sale of goods such as drugs which have expiry date.
- iv- Sale of goods at lower price on or after the date of completion of sale/placement of the or der of goods by the authority concerned.
